## COLLEYVILLE FAMILY KARATE CENTER

### MEMBERSHIP AGREEMENT

**This is a legal contract between you and the school, please read it carefully before signing!**

Colleyville Family Karate Center, (CFKC) agrees to accept \_\_\_\_\_  
as a student and to provide martial arts instruction under the following terms of membership:

1. Tuition is due and payable whether or not the student attends any classes except under the provisions of item #2.
2. Injury or illness *may* be grounds for suspension of tuition upon presentation of a doctor's note and at the sole discretion of CFKC. When the student is released from medical restriction his or her tuition will again be due to the school from that point forward. If student cannot return to training due to a permanent disability or illness, then the student's tuition shall be terminated upon written request and receipt of doctor's statement. Date of signature by doctor shall determine starting date.
3. Tuition is due on the 1<sup>st</sup> of each calendar month and is past due on the 10<sup>th</sup>. Past due tuition is subject to a \$10 late charge. Tuition rates may be changed at any time.
4. If you move more than 30 miles from the school's location, your membership may be terminated upon your written request.
5. Your membership and tuition responsibility will continue until such time as you provide 60 days written notice by certified mail of your intent to discontinue training. Failure to notify the school will cause your tuition to continue until such notice is received, and in no event will cancellation be backdated prior to the actual date received by the school or the postmarked date of the notice. During the 60 day notice period, you may continue attending all normal classes while paying your normal dues. At the end of the 60 day period you will have no further obligation to the school provided your account is current. If tuition rates are changed during your 60 day period you will continue to pay your existing tuition rates until the end of the 60 days.
6. Like all private schools we must maintain class schedules, staff, and facilities whether or not you attend class. Vacations, busy schedules, etc. are not valid reasons for failing to make your tuition payments whether you come to class or not. You must give the school notice if you wish to withdraw from training, you cannot simply stop coming to class and stop your tuition. Our 60 day policy is very liberal for a private school and we must adhere to it. Most schools require 12 month contracts or longer.
7. The school may change instructors, class times, and programs from time to time as needed without affecting your membership responsibilities.
8. There is no interest or sales tax charged on tuition. Sales tax is due on equipment.
9. Students are required to purchase approved uniforms, insignia, and equipment in accordance with school standards for safety and uniformity. You may purchase from the school or elsewhere provided the items meet the school's requirements.
